### Reporting Absences/Late arrival

If your child is going to be absent from school or arrive late, it is imperative for safeguarding reasons that this is reported to the school by 8.30am. Messages left on the main reception answerphone or sent to [info@warlinghamtl.co.uk](mailto:info@warlinghamtl.co.uk) may not be retrieved as quickly as those received directly by the Attendance Team and therefore pose a safeguarding risk.

For this reason, please do not report absences or lateness using these methods.

### Consents

When students join Warlingham School & Sixth Form, parents/carers complete a registration form providing lots of information including contact details, personal information, and consents for various activities.

We currently request consent for your child to take part in the Warlingham School & Sixth Form Sponsored Walk/Swim on an annual basis. To streamline this process and avoid asking for consent annually for this event, please complete the form via the link below by **31st January 2026**.

Parents/carers can also update this consent in the arbor app. As with all consents, you can update or change your preferences at any time using the Arbor app for parents.

### Years 7 – 11

#### Unauthorised Absences

Just to remind parents/carers that if they take their children out of school without authority for 5 or more days (which do not have to be consecutive), then the following will apply:

- If you have not incurred a penalty notice relating to this child/children in a rolling 3 year period since 19 August 2024, then the penalty notice will be charged at the rate of £160.00, per parent/carer per child, if paid within 28 days. This will be reduced to £80.00 if paid within 21 days of receipt of the notice. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.
- If you have incurred a penalty notice relating to this child/children since 19 August 2024, the rolling 3 year period will be activated from the date of the first penalty notice and the second penalty notice will be charged at the flat rate of £160.00, per parent/carer per child, if paid within 28 days. There will be no reduction for

payment within 21 days. Failure to pay the Penalty Notice will result in Surrey County Council considering legal proceedings against you in the Magistrates Court.

- If you have incurred 2 penalty notices relating to this child/children in the rolling 3 year period since the first penalty notice was issued, then you will NOT receive a third penalty notice – Surrey County Council will have no option but to consider a prosecution, per parent/carer per child, in the Magistrates Court under s 444 Education Act 1996. Surrey County Council is not responsible for authorising pupil absence and therefore cannot withdraw any Penalty Notice requests without the written permission of the Headteacher.

### **Year 9**

#### **Diphtheria, Tetanus & Polio (Td/IPV), Meningococcal ACWY vaccinations**
